

# What you need to know about Education Stabilization Funds

## Why are we here?

K-12 schools have access to federal funds in response to the global COVID-19 pandemic. These funds can be used to support many kinds of projects. This document is a primer to help you get a better idea of what ESF is, how it can benefit you in your district and next steps you can take to ensure you and your colleagues are prepared to self-advocate for resources to improve your students' reading and learning.

## What is ESF?

The **Education Stabilization Fund** was created from three federal laws:

- Coronavirus Aid, Relief, and Economic Security Act (CARES)
- Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA)
- American Rescue Plan Act (ARP/ARPA)

Funds from these laws have been allotted for all education:

- Includes targeted programs for <u>many programs</u>, including Bureau of Indian Education, Non-Public Schools, rural areas and workforce readiness
- K-12 schools have been allotted the largest share of the funds







## Who gets what?

<u>How much</u> each state (SEA) gets for ESSER is determined at the federal level. The state then assigns eligible fund amounts for each district (LEA) and can reserve up to 10% to address emergency needs.

Districts <u>must apply</u> in order to receive allocated funds from the state, and each state has its own <u>application</u> <u>process</u>.

## **ESSER** allowable uses

There are many <u>allowable uses</u> for ESSER, ESSER II and ARP ESSER/ESSER III funds. A few that might be of particular importance to educators include:

- Purchasing educational technology (including hardware, software, and connectivity) for students served by the LEA that aids in regular and substantive educational interactions between students and their classroom teachers, including assistance technology or adaptive equipment.
- Planning and implementing activities related to summer learning and supplemental afterschool programs, including providing classroom instruction or online learning during the summer months and addressing the needs of low-income students, students with disabilities, English learners, migrant students, students experiencing homelessness, and children in foster care.
- Addressing learning loss among students, including administering high-quality assessments using
  differentiated instruction, implementing evidence-based activities to meet the comprehensive needs
  of students and tracking student performance and engagement in distance-learning environments.

## What do we know so far about how ESSER implementation and use?

According to state agencies, the funds work similarly to Title I money and state librarians will focus on Institute of Museum and Library Services (IMLS) funding.

**Educators say** that the process is top down, and that teachers and school librarians do not dictate projects but can influence them.
